- Structure : RCC frame structure.
- Super structure : 1st class KB bricks/fly ash bricks
- Plastering : All inside and outside wall shall be plastered in 1:6 proportion and ceiling 1:4.
- Storage space : Suitable spaces and sizes shall be provided for cup boards.
- Door frame : Sal wood door frame of 5"x2.5".
- Windows: Alluminium glazed windows with 5mm tinted glass and protective MS grill.
- Wall finish: Internal: Putty finish with distemper.
- External : Plaster finish with weather coat paint.
- Doors : All internal doors are factory made flush door of 32mm thickness.
 and main door is 32mm flush door with teak finishing.
- Flooring: Rooms: Vitrified tiles 2'x2', Toilets: Anti skid 1'x1' ceramic tiles
- Toilet walls: 12"x8" ceramic glazed tiles up to 7' height.
